REQUEST FOR MARRIAGE LICENSE INFORMATION

You have requested to apply for a marriage license by mail or email. This office strives to meet all of our customers' needs in a timely manner. Postal mailing times cannot be guaranteed by this office. Please allow sufficient time for processing. Florida residents are encouraged to visit their local Clerk's Office.

If you have children in common born in the State of Florida, you may fill out an Affirmation of Common Children form to accompany your application.

Upon receipt of the completed Marriage License Information by Mail form below, which you submit by mail, facsimile, or email, we will send you by email or standard mail an **Application to Marry** and an **Affidavit** as to Section 741.212, Florida Statutes. *Please be expecting our email no earlier than sixty (60) days from your wedding date.* The documents must be signed by both applicants and witnessed by an official notary public prior to submission to our office for processing. Please print neatly, as it is imperative that all of the information is legible. You must also submit a copy of valid government-issued photo identification for each applicant. *Payment will be due at that time.* **This is not a valid marriage license and a legal ceremony cannot be performed at this stage.**

Lastly, if everything is in order as described above, the Clerk will issue and mail you the official and validated **License to Marry**. The license is valid for sixty (**60**) days from the date of issuance by our office. If the ceremony is not performed within the 60-day time frame pursuant to Section 741.041, Florida Statutes, the license will expire and you must recommence the entire process, which includes repayment of the application fee. No refunds are issued.
